1. Present to the court a valid Texas driver's license or permit.
2. Present to the court proof of financial responsibility (automobile liability insurance).
3. Obtain a certified copy of my driving record from the Department of Public safety.
4. Pay court costs and a \$10 (non-refundable) fee to the court for a total of **\$144.00** or **\$169.00** if violation was in a school zone.
5. Complete a driving safety course approved by the Texas Department of Licensing and Regulation within the required time.
6. Present to the court the uniform certificate of completion from the driving safety course and the certified copy of driving record by date given to you by Court staff.
7. Appear at a show cause hearing if I fail to comply with any of the above provisions.
8. If I fail to appear at the show cause hearing, the court will impose the fine, enter a judgement of conviction and may issue a warrant for my arrest.

I also understand that the charge against me will be dismissed and the court will report to the Department of Public Safety the completion of the driving safety course for inclusion on my driving record if I comply with all terms above.

The undersigned Defendant and/or Defense Attorney, upon entering a plea of guilty or no contest to elect completion of a driving safety course for dismissal of a moving violation, acknowledges that he or she has obtained disclosure of any timely requested discovery material in the State's possession pursuant to Art. 39.14 of the Code of Criminal Procedure, including but not limited to, offense and/or accident reports, audio and/or victim statements, and any other discoverable evidence that may exist.
