RENTAL INFORMATION

- Pavilions are available to reserve for any date during the year on a rental fee basis but must not conflict with Parks and Recreation scheduled uses.
- Two-hour minimum rental time is required of all reservations and **may be reserved six (6) months in advance.**
- Pavilion rental hours are 8:00am – 10:00pm but can be subject to special restrictions that may apply.
- Decorations may be taped to the structure but must be removed at the end of rental.
- Use of the pavilion is restricted only to the area that has been reserved.
- Persons making the reservations take full responsibility and all liability during the use of the pavilion for any actions or injuries of persons participating in or attending the rental or as the result of the rental.

RENTAL INFORMATION

- Pavilions are available to reserve for any date during the year on a rental fee basis but must not conflict with Parks and Recreation scheduled uses.
- A two-hour minimum rental time is required of all reservations and may be reserved six (6) months in advance.
- Decorations may be taped to the structure but must be removed at the end of rental.

- **No inappropriate behavior is allowed at City of Weatherford Facilities. All reservations are subject to be reviewed for current and future usage.**

CANCELLATIONS / CREDITS / REFUNDS

- **Cancellations must be in writing, (5) five working days or more prior to the rental date to receive a refund.**
- **Any cancellation notices of less than (5) five working days will result in forfeiture of any fee paid.**
- **If credit is given you will have ONE YEAR from date to use that credit**

FEES

- An immediate full payment is required at the time of reservation.
- Payment may be made over the phone with a Visa, MasterCard, or Discover credit card.

Park Regulations

Sec. 9-11-1. General park regulations

The following regulations shall apply to all parks within the city park system as shall exist now or hereafter be created:

1. Firearms shall not be permitted in any public parks.
2. Concert activities shall have the prior approval of the director of parks and recreation and such activity shall be required to complete a special event application and furnish proof of liability insurance documentation which shall be filed with the city secretary.
3. All individuals, corporations or businesses acting as a vendor soliciting for sale to the public any merchandise, food or produce shall have prior approval of the director of parks and recreation and shall have obtained all required city licenses or certificates as may be applicable to such merchandise, food or produce.
4. All individuals will be committing an offense if they possess any open container of alcoholic beverage or consumes an alcoholic beverage within any park or public recreation area owned by the city and designated by the chief of the police as an alcohol-free area. "Alcoholic beverage" means alcohol or any beverage containing more than one-half of one percent of alcohol by volume that is capable of use for beverage purposes, either alone or when diluted.
5. Glass containers shall not be permitted in any park, aquatic or sports area.
6. Overnight camping shall not be permitted in any city park except for the purpose of organized and scheduled activities as may be approved by the director of parks and recreation or an agent thereof.
7. The maximum vehicle speed limit for all park road areas, including but not limited to Cartwright Park, Holland Lake Park and Weatherford Lake Park, shall be posted for a maximum speed of 20 miles per hour.
8. Security gates may be provided at any park entrance for the purpose of closing and securing a park as deemed necessary by the city manager, the director of parks and recreation, the chief of police, or an agent thereof.

Sec. 9-11-2. - Horses.

1. Horses are restricted to designated riding trails and shall not be allowed to graze or go unattended, nor shall they be hitched to any rock, tree, or shrub.
2. The undeveloped part of Cartwright Park, northwest of the pavilion is a designated riding trail.

Sec. 9-11-3. - Vehicles.

1. The city council may by ordinance, resolution or minute order, designate streets, motor vehicle parking areas or riding trails and establish traffic control signs and establish time limits for parking of motor vehicles within park areas and time limits for other uses of city parks.
2. All traffic rules and regulations are applicable and enforceable in all park areas.
3. Motorized vehicles are restricted to designated streets and motor vehicle parking areas.
4. Notwithstanding the previous provisions, it shall be lawful for city maintenance vehicles and personnel to drive within any park area for the purpose of caring for and maintaining the park property; for law enforcement vehicles to drive within any part of a park when conducting law enforcement work and for any emergency services vehicle when responding to an emergency call.

Sec. 9-11-4. - Sunshine lake regulations.

1. Individuals will commit an offense if they operate a boat by means of a motor having a commercial-power rating in excess of five horsepower on the water Sunshine Lake.

2. Individuals will be committing an offense if they tow, pull, or otherwise move a person or object, including, but not limited to surfboards, sailboats or water skis on the water of Sunshine Lake, or take a jet ski or similar device on the water of Sunshine Lake.
3. The exception to (1) or (2) of this section is for individuals participating in an organized and scheduled recreational event authorized by the director of parks and recreation; for law enforcement official or an emergency service provider responding to an emergency call; or for City of Weatherford employees operating a motorboat within the scope of their employment.

Sec. 9-11-5. - Park hours.

The hours of operation for the following recreational/park areas, including all of the areas of such site, and the hours during which such areas shall be closed for all public use shall be as follows:

| All other city parks: | 6:00 AM to 10:00 PM | 10:00 PM to 6:00 AM |

Any exception to the above stated hours of operation, because of any city authorized organized and previously scheduled activities, shall be approved by the director of parks and recreation.

Sec. 9-11-6. - Athletic fields.

1. The Director of Parks and Recreation shall be authorized to designate any playing field or game field owned, leased or under the control of the city, a closed field for the purposes of maintenance or to protect the surface of a playing field or game field from damage or for any other purpose.
2. It shall be unlawful to go upon a playing field or game field which has been designated as a closed field and has posted thereon a sign stating "Closed Field - Do Not Trespass When Gates Are Locked - For Authorized Use, Contact City Park Dept. 817-598-4124- City Ordinance 2001- "except for the purpose of going upon a closed field to maintain such field.
 - (a) The Director of Parks and Recreation shall be authorized to designate fields as game fields and shall post thereon a sign stating, "Game Field - Authorized Scheduled Use Only, City Ordinance 2001-." The director of parks and Recreation shall also be authorized to remove or securely cover such signs at times when the general public may use such field.

Sec. 9-11-8. - Penalty

Any person, firm, corporation, or individual violating the provisions of this chapter shall be deemed guilty of a misdemeanor and upon conviction thereof, shall be subject to a fine not to exceed \$500.00 for each offense.
